

Texas Government Code Section:



- 551.084 Excluding witnesses from a hearing.

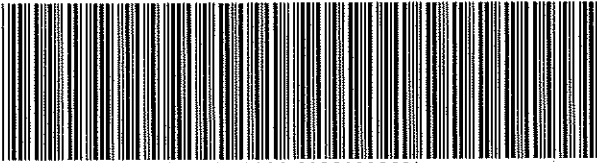

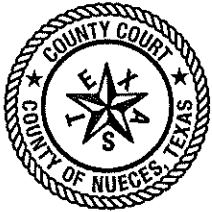
