

- 551.084 Excluding witnesses from a hearing.

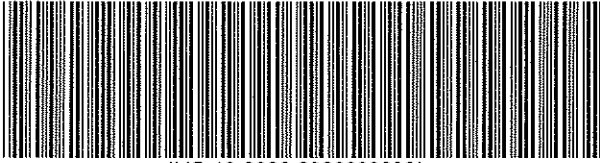
